	OSS agrees to furnish all facilities for the care and feeding of the mare while in its custody. A Foal Alert TM system will be used to monitor the mare as she reaches the final stages of her gestation, in preparation to foal. A fee of \$120.00 will be charged for the use of the transmitting device. Mare Owner agrees to pay for care and feed at the daily rate of \$18.00 for pasture mares or \$20.00 for paddock mares and \$25.00 for stalled mares. An additional \$ 2.50 per day will be charged on all wet mares in pasture; and an additional \$5.00 will be charged on all wet mares being stalled. OSS reserves the right to refuse to accept any mare that is not in proper condition, or does not have all of the records, tests, and registration documents as required herein.</u>

The undersigned agrees that OSS and its agents, officers and employees will not be responsible for accident, injury, sickness or death to the mare or its foal, whether from flood, fire, theft, acts of God, or for any other reason. The undersigned agrees to and shall indemnify and hold harmless Breeder and its officers, agents, and employees from and against any and all claims, loss, damages, causes of action, suits and liability of every kind, including all expenses of litigation, court costs, and attorney's fees, for injury or death of the mare and/or foal.
